




# STRATEGY OVERVIEW

The Crosspoint Accelerated Growth Strategy is an investment strategy that shifts between U.S Index ETF's and 100% cash based on the condition and trend of the U.S. stock market as determined by the firm's proprietary Market Sentiment Indicator (MSI). When the MSI demonstrates favorable conditions, the strategy will invest in 0-5 Leveraged Index ETFs weighted between 0-50% of the portfolio based on distinct technical parameters. When the MSI has a negative outlook, the strategy will decrease market exposure. The strategy takes exposure to the following indexes: the Nasdaq 100, S&P 500, Dow Jones Industrial Average, and Russell 2000. The primary goal of the strategy is to capture significant alpha by being invested in rising stock markets and protecting capital when risk is elevated. The strategy is designed for investors seeking high growth over a multi year period of time with minimal sensitivity to shortterm market fluctuation.



<u>Crosspoint Accelerated Growth</u> includes all discretionary accounts employing the "Crosspoint Accelerated Growth", a tactical investment strategy that seeks growth and preservation of capital through equity and cash equivalents managed by Crosspoint Capital Management. The strategy is designed for investors seeking high growth over a multi-year time horizon, with minimal sensitivity to short-term market fluctuation. Through this approach there will be periods where Crosspoint will be variously invested in equities or cash. We look at risk in terms of potential loss of capital and strive to minimize overall portfolio risk by mechanically reducing exposure in declining markets. The strategy of the composite is benchmarked to the S&P 500 total return. The minimum account size for this composite is \$10 thousand. Crosspoint Accelerated Growth was created May 1, 2017.
